INTRODUCTION

The Sikkim Human Rights Commission was constituted by the State Government vide its Notification No.101/Home/2008 dated 18-10-2008. At present, Hon'ble Mr. Justice Narendra Kumar Jain, former Chief Justice of High Court of Sikkim is holding the post of Hon'ble Chairperson, Sikkim Human Rights Commission.

PERIOD OF ANNUAL REPORT

The Commission has prepared this Annual Report for the period 01-04-2017 to 31-03-2018 for submitting to the State Government under Section 28(1) of the Protection of Human Rights Act, 1993 (Central Act. No.10 of 1994).

CONSTITUTION OF SIKKIM STATE HUMAN RIGHTS COMMISSION

Chairperson and Members of the Commission

Hon'ble Mr. Justice N.K. Jain (Former Chief Justice of High Court of Sikkim) is working as Chairperson of Sikkim State Human Rights Commission. The posts of remaining two members of the SSHRC are still to be filled by the Concerned Authority.

- Out of above allotted budget some small re-appropriation of the amount in the Budget heads were made, which has been shown in the enclosed statement.

The Commission is maintaining proper accounts and record. A monthly expenditure report is being sent by Commission regularly before 7th of each succeeding month to the State Government. A copy of Annual Statement of accounts is enclosed herewith and marked as **Annexure-III**.

Quarterly reconciliation is also being made by the Commission with the office of Accountant General, Gangtok. A copy of Certificate dated 30-05-2018 issued by the office of Sr. Deputy Accountant General (A&E) Sikkim is enclosed herewith and marked as **Annexure IV.**

It is relevant to mention that instead of paying grants to the Commission as required under Section 33 of the Protection of Human Rights Act, 1993 (For short "Act"), the State Government is allotting a budged as referred above.

It is also relevant to mention that the Accounts of the Commission has not been audited by the Comptroller and Auditor General as required under Section 35 (2) of the Act, despite telephonic request of the Commission, therefore, Audit report could not be forwarded to the State Government, as required under Section 35 (4) of the Act.

COMPLAINT RECEIVED/INSTITUTED/DISPOSED OFF

-Five complaints were pending as on 01-04-2017 before the Commission for want of report/comments/further information. During the period of Annual Report 2017-18, five pending cases as on 01-04-2017 were disposed off. However, the Commission received ten complaints during this period, out of which eight complaints have been disposed off. Two complaints remains pending for want of further information. Thus, 5+8= total 13 complaints were disposed off during this period and two complaints remained pending as on 31-03-2018. The details of complaints pending as on 01-04-2017, new complaints received and complaints disposed of

during the period of report and complaints remained pending as on 31-03-2018 are as under:-

Complaint No.11/2016 -Topzang Bhutia v/s SP West & Ors.

-The Complaint was filed by Mr. Topzang Bhutia of Hee-Goan, West Sikkim, against the Superintendent of Police West District, Gyalshing & others in respect of alleged torture by police upon him while in custody. The report called for, has been received. The complainant was not present on the date fixed by the Commission and he also did not comply with the order of the Commission. The Commission specifically passed an order that a last opportunity is granted in the interest of justice to the Complainant to remain present in person on next date and comply with the orders, failing which the complaint would be dismissed.

Written notice was sent to both the parties, however, the Complainant was neither present nor did he comply with the earlier orders of the Commission, hence, the complaint was dismissed in default as well as for non-prosecution on 19th September, 2017.

Complaint No.17/2016 -Umesh Thakur & 11 others v/s Chief Secretary & Others.

-The matter was relating to non-consideration of cases of 12 applicants/life convicts for their pre-mature release despite the fact that they completed/remained in Jail continuously for 14 to 19 years. The matter was listed on 18th August, 2017 and the Commission was informed that 10 life convicts have already been released on 15th August, 2017. The remaining 2 life convicts namely, Nanda Kishore Khanal and Bhim Lall Khanal have been released on Republic Day 2018. Since all the life convicts were released and nothing remained to be decided in the case, hence the Complaint was disposed off on 7th March, 2018.

Complaint No.21/2016 -Bhim Singh Biswakarma v/s Chief Secretary and Others.

-The Complaint was filed in respect of non-supply of G.C.I sheets, despite sanction of the same as Complainant was not having proper roof in his house. The Commission sought report from RMDD and other concerned parties regarding the matter. The Panchayat Vice President submitted that G.C.I sheets have been supplied to the Complainant, after report sought by the Commission, the evidence of which was submitted in a form of photographs showing G.C.I. sheets received by the Complainant Further, the Complainant himself filed an application for withdrawal of the Complaint mentioning therein that he has received the G.C.I sheets, after issuing notice by this Commission to Opposite Parties, therefore, the Complaint was dismissed as withdrawn on 22nd July, 2017.

Complaint No.01/2017 -Ujjal Sharma v/s P.S. Singtam.

-This Complaint was filed by Mr. Ujjal Sharma of Sumin Lingchey, Singtam, East Sikkim before Commission stating that his brother Udai Sharma who had been to Bangalore for his livelihood, is missing from Bangalore since 18th February, 2016. It appears that the so called cause of action for filing the present complaint took place at Bangalore and not in the State of Sikkim. A case had already been registered at P.S. Bangalore and efforts have been made by the Investigating Agency at Bangalore. Since matter is pending before P.S. Bangalore & P.S. Singtam, East Sikkim, the Commission found it inappropriate to proceed further. The Complaint was accordingly disposed off on 2nd May, 2017

Complaint No.02/2017 -Maya Devi Darjee v/s Ex. Engr., CWC.

-This Complaint was filed by Smt. Maya Devi Darjee against the Executive Engineer, SID, Central Water Commission, Govt. of India, Tadong, East Sikkim for not granting the interest on gratuity amount of Rs.1,23,984/- paid to her on 18th August, 2016 only after

the intervention of the Commission. A report was sought from the concerned authority. From the facts narrated by the parties based on admission and documents, it was seen that the substantive amount of interest of Rs.34,095/- has been paid to the Complainant and Opposite Party has also taken action in respect of remaining amount of interest of Rs.5,954/-. Hence, the Complaint was disposed off on 11th May, 2017.

Complaint No.04/2017 Kishan Kr. Bhujel Vs. Pr. Secy, Home Department & Ors.

-The Complaint was received from Mr. Kishan Kumar Bhujel on 6th April, 2017 regarding non-issuance of OBC Certificate to his daughter Kritika Bhujel. The report was sought from the concerned parties. The matter was then referred to the Scrutiny Committee constituted vide Notification No.26/SJE&WD dated 7th February, 2014 to examine the issue. The Additional Secretary, Social Justice Empowerment & Welfare Department informed the Commission vide letter No.GOS/262/SJEWD/WD/2017 dated 5th July, 2017 that the Scrutiny Committee has submitted its final report for consideration of the Government. The file was returned by the Hon'ble Chief Minister to the office of Chief Secretary to relook into the matter. It being a policy matter, the Advocate General sent his opinion regarding the issue to the State Government. The Deputy Secretary of Home Department as well as the Legal Retainer both submitted that they did not know whether the Chief Secretary will take a decision on his own or he will again refer the matter to other Department. The complaint remained pending for want of further decision by the State Government.

Complaint Case No.5/2017 Abhishek Gurung Vs. Yankesh Pant & Ors.

-The Complaint was received from Abhishek Gurung, General Manager, 31A Lounge, Deorali against Shri Yankesh Pant and Mr. K.R. Shanker, Managing Directors of the company on 2nd May, 2017 for delay in payment in salary and harassment. Report was

called from the Managing Directors of the Company, subsequently, the Complainant on $24^{\rm th}$ May; 2017 submitted an application for withdrawal of the complaint stating that the Opposite Parties have paid all the salaries to the staff and further agreed to give all the benefits also. Consequently the complaint was disposed off as withdrawn on $24^{\rm th}$ May, 2017.

Complaint Case No.6/2017 Ratna Maya Rai Vs.SICPA India Pvt.Ltd & Ors.

- The Complaint was received from Mrs. Ratna Maya Rai, Mamring, East Sikkim against SICPA, India Pvt. Ltd., South Sikkim on 24th June, 2017 regarding negligence by SICPA company towards injured employee. Report was called from SICPA India Pvt. Ltd. and from Labour Department, Government of Sikkim. On 11th August, 2017 an opportunity was given to the parties to settle the matter finally and place the compromise deed on record before the Commission. The representative of the company gave assurance that the company as well as the service provider both will take care of the victim in treatment and wages of the victim. The brother of the victim admitted that the treatment expenditure has been paid to the injured alongwith the wages for the month of June and July, 2017. The Commission was of the view, that the complaint/Victim/ injured should approach the appropriate forum including the Workmen Compensation Commissioner and Motor Accident Claim Tribunal for adequate compensation in accordance with law.

As far as violation of the Human Rights was concerned, the Complainant admitted that the victim has been paid the medical expenses as well as wages regularly. The Complaint was therefore, disposed off on 21st August, 2017.

Complaint Case No.7/ 2017 Bishnu Kattel Vs. DOP, Govt. of Sikkim.

-The complaint was received from Mr. Bishnu Kattel, Sakhukhani, West Pendam, East Sikkim against Department of Personnel, Administrative Reforms & Training, Govt. of Sikkim stating that his name was approved for appointment as LDC by Hon'ble Chief Minister but despite his best effort, the job was not accorded to him. A report was called from DOPART, Govt. of Sikkim. Wherein it was informed that as per the Sikkim Sub-Ordinate (Ministerial & Executive) Service Rules, 1948, the mode of recruitment to the post of LDC is 85% by direct recruitment through Open Competitive Examination, 5% by promotion on the basis of Merit-cum-Seniority from amongst Group D employees holding Grade-I post with 30 (thirty) years of Regular Service and 10 % by promotion from amongst Group D employees having a qualification of class X pass from a recognized board on seniority basis subject to availability of the vacancies. Further 12% reservation has been provided for all communities living under BPL category for the concerned post and services to be filled by direct recruitment. That as per law, the Complainant is required to appear for the post of LDC in Open Competitive Examination as an when posts are advertised. A copy of reply filed by DOPART was supplied to the Complainant. After going through the reply, the Complainant filed an application for withdrawal of Complaint on 11th October, 2017. The Commission permitted the Complainant to withdraw the complaint on 11th October, 2017. Consequently, the complaint was dismissed as withdrawn with liberty to applicant to agitate the matter before appropriate forum in case necessity so arises.

Complaint Case No.8/2017 Palmu Kazi vs.DAA, Govt. of Sikkim & Ors.

-The Complaint was filed by Ms. Palmu Kazi, Tachugang, East Sikkim against District Administrative Authority, East Sikkim & her uncles claiming her paternal rights for procuring Certificate and the share in property which were deprived to her. During the course of the arguments, the Complainant filed an application for withdrawal of the complaint with liberty to seek appropriate relief before the appropriate forum in accordance with law. Consequently, the

Commission allowed the application and dismissed the complaint as withdrawn on 10^{th} August, 2017.

Complaint Case No.9/2017 Chandrawati Devi Prasad Vs. Sharda Gupta.

-A complaint was received through e-mail from Ms. Chandrawati Devi Prasad, Singtam, East Sikkim against Ms. Sharda Gupta, New Delhi for fraud and extortion of money. However, due to non presence of the Complainant on the date of hearing the Commission dismissed the complaint in default on 14th November, 2017.

Complaint Case No.10/2017 Sachin V. Fulmari Vs. Nagpur Police, Maharashtra.

-A complaint case was received from Mr. Sachin V. Fulmari, Nagpur Maharashtra on 21st August, 2017 by speed post against Nagpur Police, Maharashtra wherein it was alleged that the Police was falsely trying to implicate him. The Commission considered the matter and found that there was no allegation about any violation of human right of the Complainant in the territory of the State of Sikkim. Furthermore, the Complainant has not supported his complaint with any evidence. As such, since the Commission has no jurisdiction to entertain the complaint in respect of violation of human rights in Nagpur, the Complaint was dismissed by the Commission on 7th October, 2017.

Complaint Case No.11/2017 Saraswati Pradhan Vs. SJE&WD, Govt. of Sikkim.

-This Complaint was filed by Ms. Saraswati Pradhan, Rongli, East Sikkim against Social Justice Empowerment & Welfare Department, Govt. of Sikkim on 20th September, 2017 for non-payment of Old Age Pension in respect of the Complainant. A report sought was received from the Social Justice Empowerment & Welfare Department, Govt. of Sikkim, wherein it was stated that the Department has asked the Complainant to submit B.P.L Certificate for consideration of her request for the Old Age Pension. However,

the Complainant did not submit the required documents as such the matter was kept in abeyance for want of the relevant documents. On the date of hearing on 8th March, 2018 the Learned Counsel for the Complainant submitted that she did not receive the report of the Department. As such, the Commission directed the SJE&WD to supply the reports to the Learned Counsel. The Social Justice Empowerment & Welfare Department, Govt. of Sikkim again submitted a detailed report on 21st March, 2018. After going through the report, the Commission felt it necessary that letter of the Department dated 2nd February, 2018 referred in it, is necessary for deciding the case, therefore, the Department was directed to place it on record. Shri K.B. Pradhan, Additional Secretary of the Department submitted that the letter would be filed immediately with an advance copy to the Learned Counsel. The Learned Counsel filed a rejoinder to the report filed by the Department which was in turn forwarded to the Department.

The Complaint remained pending as both the parties sought time.

Complaint Case No.12/2017 Kalpataru Dash Vs. Zydus Healthcare Pvt. Ltd. East Sikkim.

-Shri Kalpataru Dash has filed a complaint on 23rd September, 2017 (registered on 25-9-2017) against Zydus Healthcare Pvt. Ltd. stating that he has been given mental harassment at work place due to delay in promotion and increment. The Complainant is employed by Zydus Healthcare a private limited company, the dispute in the case is of service matter and between employer & employee. As per section 12 of "The Protection of Human Rights Act, 1993" the Commission may enquire into complaint relating to violation of Human Rights or abetment thereof or negligence in prevention of such violation by a public servant. Since Zydus Healthcare Pvt. Ltd. is not a Central Government or State Government Institution, therefore, there is no violation of human rights by any public servant. As such, the Sikkim Human Rights Commission has no jurisdiction to enquire into the complaint. Consequently, the

complaint was dismissed as not entertainable by the Commission, on 13th October, 2017.

Complaint Case No.01/2018 Jay Singh Vs. DGP, Sikkim Police & Ors.

This Complaint has been received through speed post on 28th December, 2017 in respect of suspected death of his brother late Bijay Singh against DGP, Sikkim Police and SHO, Rhenock, East Sikkim. A report was called from the both the Opposite parties. On 23rd January, 2018, the office of the Deputy Inspector General, Criminal Investigation Department, Gangtok has sent its report duly signed by the Deputy Superintendent of Police, CID Gangtok, along with post mortem report of the deceased and other documents and also the statements recorded under Section 161 Cr.PC in the case registered under Section 174 Cr.PC and the same was supplied to the Complainant by the police.

On 09/03/2018, Complainant appeared in person and submitted an application stating therein that he being satisfied with the investigation report has no grievance against anyone as stated in the complaint and he may be allowed to withdraw the complaint. Consequently, the complaint was dismissed as withdrawn on 09/03/2018.
